1.	Empanelment of Doctors with Child Care Institution	11 Doctors from Indian Academy of Paediatrics, Delhi have been empanelled for providing medical consultation to the children in CCIs.
2.	Constitution of Central Control Unit	The Central Control Unit is manned by Officers/ officials at the WCD HQ comprising of the Child Protection Unit (CPU) and is headed by the Director WCD. The CCU will be assisted by the District Task Force (DTF) headed by Nodal Officers/ District Women & Child Development Officers on a day-to-day basis.
3.	Constitution of District Task Force	District Task Force has been constituted which consists of the following : <ol style="list-style-type: none"> 1. District Officer, WCD, Delhi : Nodal Officer/Member Convener of Task Force 2. Chairperson, Child Welfare Committee Member. 3. District Child Protection Officer. Member Secretary 4. SDM, HQ (nominee of DM) Member 5. Nominee from DCPCR. Member
4.	Status of vaccination in r/o staff posted at CCIs	65% of the staff posted in various CCIs has been vaccinated.
5.	Number of children tested in CCIs	All the children are being tested in routine. However, whenever a child develops any symptom, immediate testing is done.

8.	Sponsorship programme for the children.	There is already provision for sponsorship under Section 45(4) of the J.J. Act 2015. In terms thereof all the orders being passed by Juvenile Justice Boards (JJBs) and Child Welfare Committees (CWCs) for providing sponsorship upto a maximum of Rs.2,000/- per child, for supplementary support in form of medical, nutritional and educational needs etc., are being honoured by the DWCD.
9.	Rehabilitation of Children Orphaned/ Adversely Affected during Covid 19	Advisories have been issued by the Ministry of Women and Child Development, Govt. of India. In pursuance thereof DWCD has also issued advisories to the District Magistrates, Child Welfare Committee, District/Nodal Officers and District Child Protection Officers, for strict compliance.

10.	Collaboration with PHD Chambers of Commerce and Industry for providing Mobile Testing Vans.	The Family Welfare Foundation of PHD Chambers of Commerce and Industry was approached and they have, in principle, agreed to provide Mobile Testing Vans (for Covid-19) for the use at CCIs.
11.	Collaboration with Azim Premji Foundation for providing Oxygen Concentrators and Oxygen Cylinders for CCIs.	Discussions are at final stage with Azim Premji Foundation for providing Oxygen Concentrators and Oxygen Cylinders for CCIs.
12.	Assessment of all the facilities viz. food,	The District Task Force shall visit the CCIs (both Govt and NGO-run) under their respective

	sanitation, hygiene, medicines, consumables, Doctors, Paramedics etc. at all the CCIs.	jurisdiction on regular basis to oversee the facilities and services available for the children and facilitate the management in availing support from the district authorities, CDMO , any other agencies for COVID-19 testing, vaccination, availability of medications, health equipment and medical care/ hospitalisation, as the case may be.
13.	Special counselling sessions for Children with Special Needs (CWSN)	DCPCR has requested all the Government Schools and seven Private School Associations to interact with the Children with Special Needs (CWSN) and ascertain their needs.
14.	Development of Module to ensure that the caregivers can detect a child having symptoms of Covid-19 at an early stage without making the child anxious.	IHBAS has already a module in this regard and has agreed to impart training to the caregivers so as to enable them to detect a child having symptoms of Covid-19 at an early stage without making the child anxious.
